Attendees will come away with a better grasp of concepts of gender, gender identity, and pronouns, as well as why it is a vital topic in our society today. Tips for best practices give attendees concrete actions they can implement in order to better serve patrons and colleagues across the spectrum of gender identities in their libraries.

This essential focus is codified in the Diversity section of the American Libraries Association's "Core Values of Librarianship". At the same time, the tremendous benefit of creating more inclusive libraries is becoming increasingly apparent. Everything from improving a library's ability to respond to the needs of its community to attracting a workforce with broad skills can be improved by building inclusive libraries, yet becoming competent in this area can be challenging and deeply emotional. Situations can be complex to navigate and individuals can experience shame, fear, and self disappointment. In her book, How to Be an Inclusive Leader, author Jennifer Brown describes a model for navigating self-growth in this area. The Inclusive Leaders Continuum includes four stages: Unaware, Aware, Active, and Advocate. Particularly in the Aware stage, Brown calls for "deep self-reflection and internal dialogue". One way of doing this is through intentional critical reflection, actively observing experiences often through writing, while offering practical tools for continuous learning. We will explore Brown's model, emphasizing the Aware stage and present specific reflective techniques that participants can use to increase their own competencies.

The past three years have embodied change at libraries as services have been re-envisioned in response to COVID. We will describe how an HVAC upgrade and plans for a neighboring auditorium were elevated into a major remodel of the existing library, the construction of a new library facility, and a radical change in services that will move our library from an afterthought to a hallmark space on campus. The importance of diverse data collection, relationship building, listening, opportunism, and general openness to rethinking facilities, collections and services will serve as centerpieces for the discussion. Presenters will also address managing change and diverse interests during the renovation process. The information provided can be scaled to fit any size academic or public library.

However, challenges frequently arise when trying to analyze data from across frequently siloed and proprietary data sources in a timely manner. Available toolsets, meanwhile, leave us wishing for more — many apps handle data from specific products or only harvest specific types of data.
